Fully Managed	From 15% + VAT (18% inc VAT) of gross monthly rent due throughout tenancy
Tenant Find Only	From £300 + VAT (£360 inc VAT) per individual let unit (e.g 5 bedroom house with 5 individual tenancies = £360 \times 5 inc VAT).
Renewal of Tenancy Agreement	Included within fully managed service, not required within Tenant Find Only service.
Cancellation of Management	Landlord shall pay to the Agent £500 + VAT (£600 incl VAT) fee per let unit within the property, (for the avoidance of doubt a property housing nine students for example would be a nine unit property). However if the Agent is unable to let the property within a period of 3 months from it becoming available to rent (unoccupied) and the Landlord then terminates the agreement there will be no charge to the Landlord. If the Agent has already found a suitable tenant who has not yet taken up occupation then the Landlord shall pay a fee of £500 + VAT (£600 incl VAT) per unit.
